



## RISK ASSESSMENT TOOL FOR RE-OPENING SCHOOLS DURING COVID-19

This risk assessment tool accompanies the WS Framework for Re-opening Schools, and provides some key steps which must be factored into the planning of the reopening of schools. It is expected that all steps will be completed prior to schools reopening and will be amended as appropriate in the context of any changes to government and/or Public Health England (PHE) guidance.

**Caveat: This document was produced on 18th May 2020. It is being kept under review as updated guidance is published by the Government.**

1. Schools where the premises have been closed completely since lockdown on 23 March 2020
2. Schools which have been partially open throughout the lockdown period and

The hierarchy of controls that, when implemented, creates an inherently safer system, where the risk of transmission of infection is substantially reduced. These include: -

- Minimising contact with individuals who are unwell by ensuring that those who have coronavirus symptoms, or who have someone in their household who does, do not attend childcare settings, schools or colleges.
- Cleaning hands more often than usual - wash hands thoroughly for 20 seconds with running water and soap and dry them thoroughly or use alcohol hand rub or sanitiser ensuring that all parts of the hands are covered.
- Ensuring good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach.
- Cleaning frequently touched surfaces often using standard products, such as detergents and bleach.
- Minimising contact and mixing by altering, as much as possible, the environment (such as classroom layout) and timetables (such as staggered break times)
